

Berkhamsted Cycling Club Youth Membership Terms & Conditions



I agree to abide by the rules and constitution of Berkhamsted Cycling Club ("BCC").

I hereby agree that neither **BCC** nor its agents and/or officials shall be responsible in any way for any loss, injury and/or damage occurred by myself whilst on club activities, whether or not such loss, injury and/or damage be caused by any negligence by the said club or its said agents and/or officials.

I agree that whilst participating in club activities I am responsible for my own safety and carry out Club activities at my own risk. As a British Cycling affiliated club, BCC is covered by public liability insurance. BCC's club affiliation does not confer individual club members with any insurance benefits and, therefore, all club members are required to have a Race Gold, Race Silver or Ride membership of British Cycling which provides individuals with the benefit of third party liability cover (or have membership of other schemes which include 3rd party liability insurance, such as CTC membership). I confirm therefore that I have 3rd party liability insurance.

I agree that these details may be stored on a computer database, to be used solely for the purposes of club management.

I consent that cycling/club photos of BCC members may be posted on the BCC website & BCC's Facebook pages.

I will be issued with a BCC membership card, and agree to carry it on all club rides.

I confirm that I have discussed joining **BCC** with the Ride Coordinator, and I have been on a successful trial ride with the club.

Please note that the **BCC** membership fee is non-refundable & non-transferable.

When you become a member of or renew your membership with Berkhamsted Cycling Club you will be registered for an online account with British Cycling. We will provide British Cycling with your personal data which they will use to enable access to an online portal for you (called My Dashboard) on the British Cycling website. British Cycling will use your personal data in accordance with its Privacy Notice which can be accessed at https://www.britishcycling.org.uk/staticcontent/info--Privacy-Policy-0. British Cycling will contact you to invite you to sign into and update your dashboard (which, amongst other things, allows you to set and amend your privacy settings). If you have any questions about the continuing privacy of your personal data when it is shared with British Cycling, please contact compliance@britishcycling.org.uk

As a club member your information may be shared on the club website, social media pages or in emails sent by the club. This data will only be shared in the event that either you are a club volunteer, have participated in a race or challenge event or have recorded a major

achievement. This data will be limited to your name, race results (if applicable) and details of your achievement. Limited further information about you may be included; for example, whether you have participated in a juniors' race or a women's race.

New club members are required to buy club kit within their 1st year as member and is a condition of renewing membership with BCC.
